
Passion is energy and life. Whatever we create is generated by our passion for our profession, our areas of expertise and our individual personality traits.







He mostly appreciates the positive energy of his team and the feeling of being part of a large family when working with his colleagues to deal with professional challenges.







- legal advice & assistance to all parties to a trial, during both the criminal investigation and the trial stages, before all competent authorities, including DNA (the National Anti-corruption Directorate), DIICOT (Directorate for Investigating Organised Crime and Terrorism), Prosecutors' office attached to the High Court of Cassation and Justice, Prosecutors' office attached to the Military Tribunal, during the criminal investigation stage, and the court of first instance and legal redress courts during the trial stages, respectively
- legal representation in litigation matters before Romanian courts of all levels, including the High Court of Cassation and Justice and Military Courts, or other institutions, such as the Wealth Investigation Commission attached to the Bucharest Court of Appeal and the Legal Commission operating within the Romanian Parliament's Chamber of Deputies
- legal advice and representation for major corporate clients with respect to crimes related to European funds, the capital markets regime, IP rights, M&As, corruption, tax and financial fraud, or insurance
- legal advice in connection with various client-related approaches, starting with drafting legal audits, legal opinions, memorandums on aspects of criminal law and criminal procedure, the amicable settlement of disputes in various matters, drafting/reviewing/negotiating/implementing of large-scale transactions, and up to the trial stage, as appropriate


